The Ordering Party: Zarząd Portu Morskiego Kołobrzeg sp. z o. o. *[The Management Board of the Kołobrzeg Seaport Ltd.]* hereby notifies that it plans preliminary market consultations prior to the announcement of the procedure for granting a construction work concession for "Adaptation of the Quay at the Kołobrzeg Sea Port to create a ferry terminal."

The subject of market consultations will be the preparation and evaluation of the procedure, with particular emphasis on the solutions contained in the functional and operational program.

The functional and utility program is available on the website: <https://zpmkolobrzeg.pl> and <https://bip.zpm.portkolobrzeg.pl>.

Elements to be discussed during the consultation:

- 1) the procedure for granting the concession,
- 2) estimated total revenue of the concessionaire during the term of the contract,
- 3) description of the subject of the concession contract, in particular the solutions proposed in the functional and utility program,
- 4) the contract template.

Initial market consultations will be conducted in the form of meetings between the Contractors and the Ordering Party. With the consent of the Ordering Party, consultations may be conducted remotely using the MS Teams platform.

Applications to participate in preliminary market consultations should be submitted in writing to the Ordering Party or via e-mail to sekretariat@zpmkolobrzeg.pl **by 21st July 2022.**

The Ordering Party plans to start preliminary market consultations **from 25th July 2022.**

The Ordering Party does not limit the number of entities participating in consultations, and does not formulate conditions for entities participating in consultations - all entities applying for consultations will be allowed to participate in the procedure.

Initial market consultations will be conducted in Polish.

The entities participating in the procedure will not be excluded from the concession award procedure. The Ordering Party will guarantee the principle of equal treatment of contractors by publishing information obtained by entities participating in the consultations on the website of the concession award procedure and setting an appropriately long deadline for submitting offers.

Information clause under Art. 13 of the GDPR

Pursuant to Art. 13 sec. 1 and 2 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (general regulation on data protection) (J. of L. UE L 119 of 04/05/2016, page 1), hereinafter referred to as "GDPR", you are here with informed that:

Your personal data will be processed on the basis of art. 6 sec. 1 lit. c on the GDPR for the purposes related to the preparation of the procedure for granting a concession for construction works;

the recipients of your personal data will be persons or entities to whom the documentation of the procedure will be made available pursuant to art. 18 of the Act of 21 October 2016 on concessions for construction works or services;

your personal data will be kept for the entire duration of the contract;

the obligation of providing personal data directly concerning you is a statutory requirement related to participation in the concession award procedure;

decisions related to your personal data will not be made in an automated manner, in accordance with art. 22 on the GDPR;

□ you have following rights:

- pursuant to art. 15 of the GDPR, the right to access your personal data;
- pursuant to art. 16 of the GDPR, the right to rectify your personal data;
- pursuant to art. 18 of the GDPR, the right to request the administrator to limit the processing of personal data, subject to the cases referred to in art. 18 sec. 2 of the GDPR;
- the right to lodge a complaint to the President of the Personal Data Protection Office, if you feel that the processing of your personal data violates the provisions of the GDPR.

□ you are not entitled to:

- in connection with Art. 17 sec. 3 lit. b, d or e of the GDPR, the right to delete personal data;
- the right to transfer personal data referred to in art. 20 of the GDPR;
- pursuant to art. 21 of the GDPR, the right to object to the processing of personal data, as the legal basis for the processing of your personal data is art. 6 sec. 1 lit. c of the GDPR.
